### **NOTICE TO EXHIBITORS**

**ENTRY FEES:** \$75 entry fee for TD and \$115 for TDX. Fees include AKC recording and service fees. Send entries with checks and applicable certifications payable to Golden Retriever Club of Illinois (GRCI). Mail to: Betty Smith, 28W085 Cantigny Drive, Winfield, IL 60190. Do not send entries by any method requiring a signature for delivery or by fax.

**CLOSING DATE FOR ENTRIES** is Thursday September 28, 2017 at 12:00 PM, after which time entries cannot be accepted, cancelled, altered or substituted.

**ELIGIBILITY TO ENTER AKC Certification Form:** Certification statements, dated within one (1) year, must be sent with entry forms for dogs entering the TD test.

**USE THE OFFICIAL AMERICAN KENNEL CLUB ENTRY FORM** Entries not on an official AKC Entry Form and photocopies of forms without the agreement and Rules on the reverse side of the official AKC form are not accepted.

**ENTRIES FOR THIS TRACKING DOG TEST** shall be accepted until the official closing date, even though the advertised limit has been reached. Preference will be given first to Specialty Breed (Golden Retrievers) without a title and then to other breeds without a title. If entries received exceed the test limit of 7 dogs, a drawing will be held September 28, 2017 at 6:00 PM at the home of Betty Smith, 28W085 Cantigny Drive, Winfield, IL 60190, to determine which entries will participate in the test. This drawing, conducted by the test secretary, shall be completely at random from among the entries received. When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above.

All entrants and the first three alternates for each test will be notified by email or telephone with the results of the draw. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test. All entrants will be advised by email with draw number and directions to the site. In the event an accepted entry cancels after the closing of entries, the test secretary shall contact alternates in the order of their placement on the alternate list. No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry. Non-participating alternates' fees will be returned within one week after the test.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the test secretary to determine if alternates are present and to determine, by their position on the alternate list, which of the alternates will participate.

**INCLEMENT WEATHER:** In the event of extreme weather conditions the Club may take such action as necessary to protect the health and safety of the dogs, handlers and judges, including postponement or cancellation of the test.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

**INSTRUCTIONS**

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, Parti-color), Beagles (not exceeding 13 in. over 13 in but not exceeding 15 in.), Dachshunds (long-haired, smooth, wirehaired), Collies (rough, smooth), Bull terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements of a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
