From the West: Take I-90 to Marengo/Hampshire Exit-Rt 20. Turn right onto Rt 20. Turn right onto Allen Rd to the Forest Preserve. From the East: Take I-90 to Huntley Exit-Rt 47. Turn left onto Rt 47. Turn right onto Rt 20. Turn left onto Allen Road to the Forest Preserve. From the North: Take Rt 47. Turn right onto Rt 20. Turn left onto Allen to the Preserve. From the South: Take Rt 47. Turn left onto Rt 20. Turn left onto Allen Rd to the Preserve.

INCLEMENT WEATHER In the event of extreme weather conditions the Club may take such action as necessary to protect the health and safety of the dogs, handlers and judges, including postponement or cancellation of the test.

NOTICE TO EXHIBITORS

ENTRY FEES: \$75 entry fee for TD and \$115 for TDX. Fees include the AKC recording fee. Send entries with checks payable to Golden Retriever Club of Illinois. Mail to: Donna Bihner 2N987 Beith Rd, Elburn IL 60119. Do not send entries by any method requiring a signature for delivery or by fax.

CLOSING DATE FOR ENTRIES is Thursday September 29, 2016 at 12:00 PM, after which time entries cannot be accepted, cancelled, altered or substituted. Preference will be given first to Specialty Breed (Golden Retrievers) without a title and then to other breeds without a title.

ELIGIBILITY TO ENTER AKC Certification Form

Certification statements must be sent with entry forms for dogs entering the TD test. The statement of certification must be dated within one (1) year.

USE THE OFFICIAL AMERICAN KENNEL CLUB ENTRY FORM Entries not on an official AKC Entry Form and photocopies of forms without the agreement and Rules on the reverse side of the official AKC form are not accepted.

ENTRIES FOR THIS TRACKING DOG TEST shall be accepted until the official closing date, even though the advertised limit has been reached. If entries received exceed the test limit of 7 dogs, a drawing will be held September 29, 2016 at 6:00 PM at the home of Donna Bihner, 2N987 Beith Rd, Elburn IL 60119, to determine which entries will participate in the test. This drawing, conducted by the test secretary, shall be completely at random from among the entries received. When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above.

All entrants and the first three alternates for each test will be notified by telephone with the results of the draw. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test. All entrants will be advised by mail with draw number and directions to the site. In the event an accepted entry cancels after the closing of entries, the test secretary shall contact alternates in the order of their placement on the alternate list. No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry. Non-participating alternates' fees will be returned within one week after the test.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the test secretary to determine if alternates are present and to determine, by their position on the alternate list, which of the alternates will participate.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
